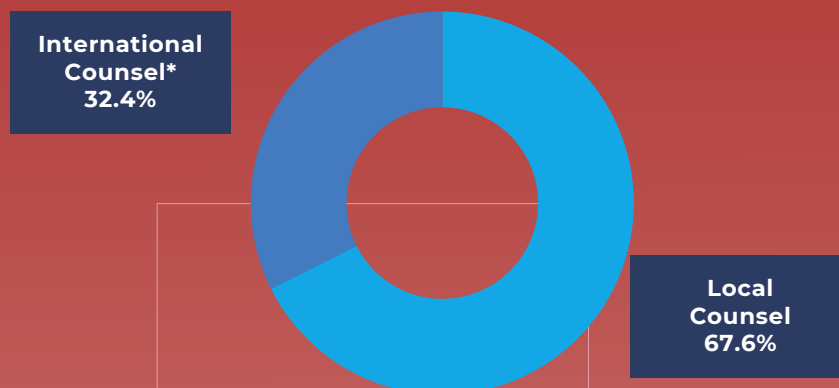
## Designation Level
